In accordance with the requirements of the ESSR III as well as requirements related to the writing of the 2021 Local Control and Accountability plan, Columbia Union School District sought input from individuals and agencies within the Columbia community. This included through surveys to staff as recently as September 2021, and previous survey review of information reported through LCAP reporting timelines. Input was provided by parents, students, teachers, staff, administrators and the bargaining units during the development of the LCAP plan that has also been used in the development of the ESSER III plan. Families that speak a language other than English were informed of the opportunity to provide input through our school messenger system that provides translated information to parents. While developing the ESSER III plan, Columbia Union School District also sought input from individuals or agencies representing the interests of Tribal Youth, Homeless and Foster Youth, youth who are low-income, youth who are incarcerated, students with disabilities, students of color, and students who are English Learners. Input was also received from community organizations and partners such as the Yes Partnership and ATCAA, the Amador-Tuolumne Community Action Agency. This outreach occurred during the time period of September 8-September 17, 2021. A survey for written responses was created and distributed during a meeting of the Student Attendance Review Board Members, which represent a number of agencies working with youth in the community, and with follow up emails as well as direct outreach to other community agencies and representatives through email and phone calls.

A description of how the development of the plan was influenced by community input.

The development of the plan was influenced in the following ways by input received from students, families, school personnel, community organizations and representatives of student groups identified above:

- * A major area of concern among staff members and families alike revolved around staffing. Stakeholders shared a common desire for the district to create and implement an intervention teaching position in order to mitigate learning loss in a manner that is concurrent with the school day. A concern was expressed that this person be provided with proper supplies, training, and support staff in order to most equitably serve students who have lost learning due to the complications presented by distance learning and the pandemic.
 - * Teachers expressed an interest in increasing opportunities for students to accelerate or remediate using learning apps and digital tools.
 - * Teachers expressed an interest in the availability of extended teaching tools to support interventions within the classroom.
 - * Stakeholders expressed a desire to see a new outdoor classroom constructed in order to allow opportunities for outdoor teaching as well as shade and weather coverage for outdoor dining.
 - * Stakeholders recognized the need of our student and staff community to meet the social and emotional needs of students and have therefore suggested opportunities for self-expression and school wide systems of support. This is also in full alignment with the LCAP.
- The input from stakeholders influenced the plan development as evidenced in the actions including a new intervention teacher position, the purchase of instructional technology, establishing an outdoor classroom, and the purchase of materials and curriculum.

Introduction
